Evelyn Scott School learners from Year 2 to Year 10 will join together to participate in the ESS Athletics Carnival for 2025 on Thursday 26 June. The Athletics Carnival is an important annual event in the Evelyn Scott School calendar.

All learners are expected to attend this day and will be supported to participate in various running, jumping and novelty events.

We will travel to and from Woden Athletics Park together, via charter bus on the day. Please ensure your child/children arrive to school on time as the bus will not be able to wait.

Learners will need to pack enough food for their day (no canteen facilities will be available) as well as a water bottle, warm clothing and appropriate footwear for participating in events/activities.

Learners are supported and encouraged to wear their Bunji colours on the day to represent our four ESS Bunjis: **Norris** (green), **Rigby** (purple), **Golgerth** (light blue) and **Felstead** (orange)!

<b>WHAT TO BRING:</b>	Plenty of food for the day, a refillable water bottle, appropriate footwear and warm layers for times between events. Bunji colours are encouraged!

Please note that a minimum number of attendees is required for this activity to go ahead. If numbers are not reached by the due date, the principal may be required to cancel the planned activity. In this circumstance, families will be notified by email.

Code of Conduct and Parental Agreements:

*Staff accompanying students on excursions will take all reasonable care while the students are in their charge to protect them from injury and to control and supervise their behaviour and activities.
