# WOMBAT SONGLINES - PRESCHOOL EXCURSION

## **DESCRIPTION:**

Evelyn Scott School preschool learners will be attending Birrigai's very exciting Early Childhood **Wombat Songlines Program**. This is a brand new program aimed at integrating Aboriginal and Torres Strait Islander history and cultures, while connecting preschool learners to Ngunnawal Country. Preschoolers will be taught a song about a wombat's journey to guide their own travel and learning on Ngunnawal Country. They will develop an awareness and appreciation of Aboriginal and Torres Strait Islander knowledge, sharing traditions through the concept of Songlines. Our learners will discover how reading Country can tell us about changes in weather and how the local plants can help us when we are hurt or sick, and how we care for Country. We will celebrate our new knowledge by cooking and sharing stories around a campfire.
