MULLIGANS FLAT GUIDED WALK - YEAR 7

DESCRIPTION:

As part of our Term 2 Global Concept "Environmental Stewardship", Year 7 learners and teachers will be taking part in a 3km guided walk at the Mulligans Flat Woodland Sanctuary. With a focus on the cross-curricular priority of sustainability, learners will have an immersive experience learning about the impacts of human settlement on the biodiversity of the area, and what initiatives have taken place to alleviate ecological disasters. The excursion will target Science and HASS learning outcomes and inform upcoming projects.
